5.4 TRIAL CHANGES TO SCORING FORMAT ON WEDNESDAY EVENINGS

Following feedback from members and a proposal made to the Committee, there will be a trial of removing the %'s from the Bridge Mates at the end of each board on the Wednesday Evening Duplicate sessions. Members will still be able to view their final % at the end of the session, as well as the finalised per-board % via the email they receive from Pinaola.

A summary of the reasons for this change are as follows:

- (a) the %'s create unkind conversations at the table by putting another pair down (e.g., "they got 0% for that partner";
- (b) the %'s are wrong and misleading, especially in the early boards of a session as not all tables have played the board (e.g., a 100% in round 3 can easily become a <50%); and
- (c) the discussions around % impair the integrity of sessions (e.g., "well we had 12 tricks partner but how do we bid it" followed by every table within ear shot bidding the slam).

It is the hope that removing these %s (but still showing the contracts) will reduce these issues in part. Future trials may consider removing the contracts as well.

MOTION: That %s be removed from the results screen in between boards on the Wednesday Evening Duplicate Session, including the Supervised Session, for a trial period until the end of December 2024.
